Simply put, biomedical research is a life saver and job creator.

Organ transplantation, which has saved and enhanced the lives of more than 600,000 people in the United States, would have never been possible without Congressional, Agency and private sector support. Medical research supported by the NIH fueled and ultimately led to the creation of the field of organ transplantation. In addition to saving and extending lives, organ transplantation has also generated substantial savings to the Medicare Program through the foregone need for dialysis. Without steady and sustainable support for NIH, much of the past progress and future achievements will soon go unfunded and discontinued. Without investments by the NIH, important discoveries in areas such as "tolerance" would likely have never been made....and there would have never been a life saving field of organ transplantation.
